## **Water/Sewer Rate Increase**

Starting August 1, 2025
Increase water rate 2% (\$.37) to 19.11 per 1000 gallons or \$38.22 per 2000 gallons or minimum charge per month
Increase sewer rate 2% (\$.40) to \$20.88 per 1000 gallons or \$41.76 per 2000 gallons or minimum charge per month
Lead and Copper fee stays the same at \$.81 per month
(until the State of Minnesota changes it)
Storm water flat rate at \$9.00 per month (up \$.25)

## **ORDINANCE NUMBER 105C**

AN ORDINANCE AMENDING THE POLICY AND PROCEDURE FOR UTILITY BILLING AND COLLECTION The City Council of the City of New Auburn, Sibley County, Minnesota, hereby ordains: SECTION 3. METER READINGS

- 1. The City is responsible to take all meter readings (except for summer outdoor meters). All meter readings will be taken by the last business day of the month.
- 2. All water meters connected to the water system shall be accessible to the city or its designee at any reasonable hour of any business day, and the refusal of admission by any owner or occupant of any premises wherein a water meter is installed after such owner or occupant has been notified that admission is desired for the purpose of inspecting a water meter installed in said premises shall constitute a violation of this chapter and the owner or occupant is prohibited from obstructing the meter so as to prohibit the reading or repairing of the meter.
  - a. Any person convicted of violating this Section is guilty of a misdemeanor and shall be punished by a fine not to exceed one thousand dollars (\$1,000.00) or imprisonment for not more than ninety (90) days, or both, plus the costs of prosecution in either case.
  - b. If the City is unable to access the premises for the purpose of maintaining or repairing of the water meter, or related hardware, following thirty (30) days written notice to the property owner, the City shall have the power and authority to discontinue water service to said premises.

This ordinance is in effect upon adoption and publication as required by law. Passed by the City Council of New Auburn, Minnesota this <u>14 day of July, 2025</u>.
